



## From the Desk of:

### COMMUNITY COMPREHENSIVE PLANNER

Greetings Missanabie Cree First Nation Family and Friends

I hope this newsletter finds everyone well and readied for spring. It certainly has been a cold and snowy winter and a very busy season for many of us.

In this edition of the BearFax, I am pleased to provide a summary report of activities and progress that has been made over the last year in the advancement of our Comprehensive Community Planning efforts.

The following points highlight the progress conducted as part of the CCP process through consultation with leadership and staff, as well as with community representatives.

To date we have had (3) meetings with the CCP Subcommittee members held in August, October and February and 6 Community Hub Information Sessions.

During our meeting of August, I had presented a historical overview of our CCP process and reviewed all the changes and challenges of our progress since 2014.

In our October sessions, CCP members and invited community members participated in a rapid review of capacity for nation building and community development by reviewing the goals and strategies described in our Community Story and had identified three priorities that could be actioned in each of the community development sectors.

During our meeting of February, we reviewed the status of these identified priorities and all CCP development actions to date in descriptive detail. This was very helpful in providing further clarity related to the priorities that have been actioned in the past year by our leadership and band staff.

Several presenters were also on hand to provide information related to regional resource developments and opportunities occurring in the forestry and mining sectors in our territory. These presentations were wrapped into a special workforce development segment of the CCP session that was open to all members in the Sault Ste. Marie area to attend.

This session is part of an ongoing regional collaboration to create and implement a workforce development strate-

gy in the Northeastern region of Ontario which will provide training, enhanced supports and on-ramps for employment in various resource sectors. This project is still a work in progress and will require further engagement with community members as we build on the strategy.

If members have not yet completed the Regional Forestry survey that has been posted on our website and in the BearFax, I highly encourage you to do so. These statistics are required to help us to develop programs, services and training programs that will serve to meet our membership needs and wants. Even if you're not specifically interested in working in the Forestry sector, your responses will help us identify challenges and obstacles related to seeking and/or retaining employment.

Part of the many challenges that I recognize in community planning is communication. It is also my belief that in order to make good decisions we need to have good information. Thus being the case, I approached these sessions with this in mind and decided to open the floor to communicating what is happening in our community on a larger, regional scale.

I realize this was not expected by the participants in attendance and some were confused with the change up from previous sessions although it was a great opportunity to bring members up to date on recent activities and developments that have or will at sometime in the future have an impact on us.

Deb Clement facilitated a very important session on Bill S-3 which will have significant bearing on our membership and the status of future generations. She has communicated this information to members at various Community hub sessions to date and will be conducting a session with Sault Ste. Marie members at the end of March.

David Flood, the General Manager of Wahkohtowin GP Inc., was also on hand to talk to members about the organization, opportunities and activities of the Forestry focused entity to which MCFN is a co-owner.



## From the Desk of:

### COMMUNITY COMPREHENSIVE PLANNER CONTINUED.

David also spoke to members about developing a consultation forestry framework that serves the needs and aspirations of our First Nation communities which will result in greater opportunity and controlling interest over forest planning and management activities. As sawmill owners and partners in an enhanced sustainable forestry licence process that is underway in our back yard, we are no longer in the back seat, but rather in the drivers seat, which has been our intention and focus for more than 20 years now.

Further on the CCP Strategic planning front, I have been steadily working with community hub groups in strengthening program and service supports available to members outside the Sault Ste. Marie area. Community hub Coordinators are now in place for Toronto (Victoria Pezzo), Thunder Bay (Deb Ewing), Sudbury (Julien Bergeron), Wawa/Missanabie (Shirley Horn) and a Regional Coordinator placed in Sault Ste. Marie. (Shelly Fletcher)

The role of these Coordinators involve; communicating and planning community hub activities and events; developing a communication channel to engage members in those areas (facebook group); generate and maintain a local members contact list; communicate upcoming events happening in each hub community; coordinate local activities and get together; post MCFN events and surveys; provide direct link to band office staff and resources.

Over the last year, the Family Wellness team at MCFN has grown substantially. As a result MCFN is able to provide enhanced supports and services and greater access to resources for members. As part of the CCP session and Information sessions that have been delivered in the hub communities to date, the Family Wellness team was on hand to provide an over view of available programs, and supports available to members and a presented a calendar of planned activities in the coming months.

For membership information, all presentations, reports and surveys will be uploaded to our MCFN website. I invite members to review them and encourage members to complete these surveys so we are able to develop a socio-economic profile of our membership that will help us in future program planning.

So where do we go from here? According to Plan.....

Our Comprehensive Community Plan is merely our guide. What we choose to action is dependent on available resources, current realities, capacity, time and effort and a genuine willingness and commitment to support the strategies and goals of the CCP.

The plan, defined goals and strategies have been laid out by membership and as CPP Coordinator, I will continue to work with leadership, staff and members in the continued advancement and implementation of our Comprehensive Community Plan. Stay tuned!

## From the Desk of:

POST SECONDARY EDUCATION OFFICER / INDIAN REGISTRATION ADMINISTRATOR

### Education

In between doing the Indian registration duties, the community sessions and supporting Missanabie Cree First Nation post-secondary students, my other job-related responsibilities include attending education meetings that will or may impact the members into the future. Some parents of members from other communities have been in touch with me regarding their children's education challenges, eligibility for post-secondary support and other related matters as well.

Attended a recent NAN meeting in Thunder Bay that continues to work on the larger issues of what First Nations communities in Ontario need to continue providing good quality educational opportunities to their membership. We continued our discussion on what the future funding channels can look like as well as sharing the successful strategies that have been providing more supports to the students. We do not anticipate the regional formula to be implemented this coming April as it still needs some work: it is not proposed to be a "one size fit all" solution. Such a formula will not work based on factors such as geography, transportation costs, housing availability in community, status of the school buildings and on-reserve populations.

Current post-secondary students are wrapping up the end of their academic year: finals will soon be upon them. Am anticipating that about six (6) members will be graduating some time this year. Not all will be graduating in the spring as their start dates or end dates differ. Some are in their third level studies – a few undergraduate level or diploma seekers have either with-drawn or will not be completing their programs. The program only supports those who meet the criteria for funding. Deferred applications were funded when additional funding became available. We do not get additional funding every year. Not everyone who inquired about available funding completed their applications.

Deadline for all continuing and new applicants for the 2019-2020 academic year is May 15<sup>th</sup> for a September start. The academic year starts in September and ends in the following April unless the official program states differently in writing. All applicants will receive their official notice of approval or denial for funding by the end of June – sooner if possible or applicable. Approved applicants are those who meet the criteria for funding. Funding is not guaranteed – maximum limits still apply. The budget is distributed first to those who submit their applications by May 15<sup>th</sup>. All late applicants are subject to funds available as are the requests for extra book money.

All prospective students need to ensure that their program of choice meets the criteria for funding and that their post-secondary institution is an approved and accredited institution. Please use the appendix as your guidelines for living allowances and books. Although we would like to be able to have increases to the monthly living allowances and books, the budget may not allow for such increases. At the time of writing this report, the budget for the 2019-2020 academic year is unknown.

An anticipated surplus for current academic year will be divided and allotted to current year's successful students – there are limits to what can be deferred and all the funds need to be spent according to the criteria. Individual notices will go out to those who qualify for a one-time bonus. If you do not receive a notice, you do not qualify for a bonus. Good luck to all current post-secondary students. Please remember to send your transcripts. If you have questions, please contact me directly. When you leave me a telephone message, please leave a current contact number.

### Membership for Indian Registration

Bill S3 came into effect in December 2017 – it resulted from a court case in Quebec. It did make some changes that address some of the inequities in the Act. And we have been informed that the Judge in the Quebec case (Descheneaux c. Canada) has stated that other inequities are there that also need to be addressed.

There is a short-term process in place called “Collaborative Process on Indian Registration, Band Membership and First Nation Citizenship”. The bulk of my report is due on March 15<sup>th</sup>. This task was given to me at the end of November 2018 to complete by mid-March 2019. The Minister of Crown Indigenous Relations Northern Affairs Canada will be presenting the Special representative’s input into her report to Parliament on June 12<sup>th</sup>, 2019.

Some discussion points that were identified include the removal of the 1951 cut-off date, the second generation cut-off rule – category 6(2), unknown or unstated paternity, enfranchisement situations, deregistration, cross-border issues, registration of children for same sex parents, adoption, gender identity impacts, the continued and future role of the Federal government in determining status, future role of the First Nation Band(s) in determining own membership or citizenship or Indian status.

I’m in the process of writing the report for the Special Representative of the Minister that is due on March 15<sup>th</sup> – the report will be mostly what Missanabie Cree members have said on some of the inequities and when and how they could/should be addressed, mitigated, removed or implemented. My report will be made available to membership. Although the bulk of my report is due on March 15<sup>th</sup>, the Special representative to the Minister did tell me directly that it was okay if I submitted some more stories a little bit late – on the condition that the bulk of my report was in on time.

To find out what effects that Bill S3 had on your status or your children’s and perhaps grandchildren’s eligibility to status, you may need to refer to the “fact sheets” that are available on line – am not sure if full booklet is available on line but I do have a copy in the office that can be shared. These were shared at some of the sessions held in January and February of 2019.

The plan is to have one more session on March 30<sup>th</sup> in Sault Ste Marie: venue still to be determined. This is open to all Missanabie Cree members and their families who live in the area. Unfortunately, we do not have the budget to assist with travel costs if any are incurred by members and their families. Please stay tuned to the Missanabie Cree First Nation website or official Facebook page for the details for the March 30<sup>th</sup> meeting – this is being set up in collaboration with our Hub coordinator and Comprehensive Community Planning Coordinator.

You may also call me at the office to discuss your situation. Some updates to status have been sent to the office and these are being added to those individual’s records.

**POST SECONDARY EDUCATION OFFICER / INDIAN REGISTRATION ADMINISTRATOR****Membership for Indian Registration CONT.****What is section 6?**

Section 6 of the *Indian Act* defines how a person is entitled to be registered under the *Indian Act*. The federal government has the sole authority, through the Indian Registrar, to determine who is entitled to be registered. Persons registered with Indian status are eligible for services and benefits delivered through federal departments. Although registration is divided into two primary categories, which are commonly known as sections 6(1) and 6(2), individuals registered under sections 6(1) or 6(2) have the same access to services and benefits.

**What is the difference between 6(1) and 6(2) status?**

A person may be registered under section 6(1) if both of their parents are or were registered or entitled to be registered. There are 14 categories under section 6(1) which identify how someone is entitled for registration.

**Overview of Sections 6(1) and 6(2) of the *Indian Act***

6(1)(a) Entitlement of person who was registered or entitled to be registered on or before April 17, 1985.

6(1)(b) Entitlement for individuals who are members of a group declared to be a Band after April 17, 1985.

6(1)(c) Reinstatement of individuals whose names were omitted or deleted from the Indian Register, or a band list prior to September 4, 1951, because of:

- the “double mother” provision;
- the person was a woman who married a non-Indian;
- the person is a child omitted or removed due to their mother marrying a non-Indian; or
- the person was removed by protest due to being the illegitimate child of a man who was not an Indian and a woman who was an Indian.

6(1)(c.01) Amending the status of children whose parent was an enfranchised minor child.

6(1)(c.02) Amending the status of children whose parent was enfranchised because of the “Double Mother Rule” and amending the status of children of an Indian grandmother who parented out of wedlock with a non-Indian.

6(1)(c.1) Amending the status of children whose mother lost status due to marrying a non-Indian man.

6(1)(c.2) Amending the status for children whose parent is registered under 6(1)(c.1).

6(1)(c.3) Amending the status of children born female to Indian men out of wedlock.

6(1)(c.4) Entitlement for children with a parent entitled under 6(1)(c.2) or (c.3).

6(1)(c.5) Entitlement for grandchildren whose grandmother is entitled under 6(1)(c.3) and a parent is entitled under 6(1)(c.4).

6(1)(c.6) Entitlement for a child whose parent is entitled under 6(1)(c.02) and grandparent was removed by protest due to being the illegitimate child of a man who was not an Indian and a woman who was an Indian.

6(1)(d) Reinstatement for an individual who was enfranchised by voluntary application prior to April 17, 1985.

6(1)(e) Reinstatement for an individual that was enfranchised prior to September 4, 1951 for reasons of living abroad for 5+ years without the consent of the Superintendent General or becoming ministers, doctors, lawyers (“professionals” – only until 1920).

6(1)(f) Entitlement for children with both parents entitled to registration.

6(2) Entitlement for children when only one parent is entitled to registration under 6(1) and the other



We have a vision of a Nation of people who respect the dignity of all; a people who find balance through equality of all ages, male and female alike.

We have a vision of people who respect the environment, harvesting and reaping the resources of the land in a sustainable manner as responsible stewards for the use of future generations.

We are the Anishnabe of the Missanabie Cree First Nation whose vision it is to regain and restore our rightful place and through the strength of our people, never again be denied our place in society.
